3. Citizen's Public Forum. (3 minutes time limit per Individual).
4. Public Hearing on the proposed 2022 tax rate. (3-minute time limit per person)
5. Discussion and appropriate action to adopt the budget for the 2022 – 2023 fiscal year.

Levying the ad valorem taxes for the 2022 Tax Year at rate of \$0.10 per \$100.00 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services District No. 12 to provide revenue for maintenance and operations needs for the 2022 – 2023 fiscal year; and at a rate of \$0.00 (zero) per \$100.00 assessed valuation on all taxable property within the legally established boundaries of Bexar County Emergency Services Districts No. 12 to provide revenue for debt services needs for 2022 -2023 fiscal year THIS TAX RATE WILL RASIE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEARS RATE. THE TAX RATE WILL EFFCTIVELY BE RAISED BY14.70 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$34.25.**
