Commissioner Ochoa made nomination for Commissioner Strzelczyk to be elected President, Commissioner Pena second the nomination. Approved unanimously.

Commissioner Latka made nomination for Commissioner Ochoa to be elected Vice President, Commissioner Pena second the nomination. Approved unanimously.

Commissioner Ochoa made nomination for Commissioner Chambers to be elected Secretary. Commissioner Pena second the nomination. Approved unanimously.

Commissioner Latka made a nomination for Commissioner Pena to be elected Treasurer. Commissioner Chambers second the nomination. Approved unanimously.

Commissioner Ochoa made nomination for Commissioner Latka to be elected Assistant Treasurer / Assistant Secretary. Commissioner Chambers second the nomination.

Approved unanimously.

6. Discussion and possible action on any changes with banks, signature cards, bonds, with the change of election of officers of Board of Emergency Service District No. 12.

Discussion was brought up about adding a fourth signature to the signature cards. Commissioner Pena had made comments that we did not need a fourth signature on the cards. 7. Discussion and possible action on Insurance needs for the District and value of vehicles.

Discussion was brought up by ESD Operation manager of the changes needed under insurance policy Crime. Public employee dishonesty for blanket per employee and blanket per loss needs the limits made to \$1,000,000 per each. This covers all employees

and each ESD commissioner. Commissioner Latka made the motion to change the amounts presented. Commissioner Pena second the motion. Approved unanimously. Discussion was brought up by ESD Operation manger to review vehicle values due to insurance renewal is coming up, it was discussed vehicle amounts presented for each vehicle. Commissioner Ochoa made the motion to make changes as presented, Commissioner Latka second the motion. Approved unanimously.
